# Executive Summary

The 2022 Amani Initiative Annual report covers a period when Uganda fully opened its economy for business after nearly two years of pandemic-related lockdown. It also comes at a time when the organization is marking her 10 years (2012-2022) of existence and commitment to prevention and response to harmful practices and barriers against children and women with a focus on teenage pregnancy and child marriage particularly in Uganda.

During this period, the organization focused on programs dedicated to the response of the effects of the Covid-19 lock down to children and women through implementation of 7 strategic projects. These included:-

1. Right2Grow
2. School Financial Health Program.
3. West Nile HIV project
4. Empowered Voices
5. Amplified Community Action against Teenage pregnancy and Child Marriage.
6. Foundation for Learning and Empowerment
7. HIV and Malaria Control Activity

Through these projects a total of 145,045 people across 15 districts of Uganda were engaged through a network of 62 partners, 1794 low cost schools, 12 health facilities and 4 community groups.

The annual report also gives a highlight of our 2022 financial investment. In 2022, we realized an increase of our total income received by 24% and increase in our expenses by 18% as compared to our 2021 financial report. This is a significant evidence of the importance of the work we do.

In the annual report you will also find some of the community voices that continue to inspire and direct our work, the list of the 62 partners we directly collaborated with and the team at Amani Initiative behind some of the work in the report.

In conclusion, 2022 was an important year where we celebrated our 10 year anniversary, hit incredible milestones in regard to impact but also launched our 2023-2027 strategic plan dedicated to accelerating our efforts to end child marriage and teenage pregnancy in Uganda.

# Board of Director's Message

I am pleased to present the Amani Initiative's 2022 Annual Report, as we celebrate a significant milestone - our 10th anniversary.

It is with immense pride and gratitude that we reflect on the progress made in the past year and the positive impact we have achieved in our mission to prevent and respond to harmful practices against children and women with a focus on child marriage and teenage pregnancy. 2022 also marked the first year when the country was fully open after Covid-19. I sincerely appreciate the 62 partners with whom we closely engaged in 2022. I particularly appreciate Girls First Fund, Edify Uganda, PeaceCorps Uganda, Infectious Diseases Institute/CDC, Aga Khan Foundation, the Hunger Project Uganda, Movement for Community Led Development, Girls Not Brides Uganda, Save the Maracha Girl, Maracha District Local Government, Arua City Council, and Joy for Children Uganda with whom we directly implemented the 7 projects we are celebrating in this annual report.

As we embark on our 2023-2027 strategic plan, we enter a new phase of growth and impact. Our strategic plan aims to reach and positively impact over 1,500,000 individuals within 2023-2027. We are committed to expanding our programs, strengthening our partnerships, and advocating for policy changes to create a society where child marriage and teenage pregnancy are relics of the past.

In closing, I would like to express my deep appreciation to our dedicated team, volunteers, and supporters who have been instrumental in our journey thus far. Together, we have achieved remarkable results in 2022 but the journey is still long. I strongly believe together we shall be able to reach this journey of a Ugandan society free of teenage pregnancy and child marriage.

Through these projects, we realized our annual expenses growth by 18%. Our average investment per client or beneficiary within 2022 was Ugsh 29,784 which is \$8. Hence we were able to do more with the little we had.

I extend my heartfelt gratitude to each and every one of you for your generosity, expertise, and commitment to the cause of ending child marriage and teenage pregnancy. # A Year in Review

2022 marked our 10 year anniversary as a registered local organization in Uganda. In our review we share the amazing milestones reached on child protection with our community change agents, the impact of our educations systems strengthening on child protection and school financial management. The impact of our community facility linkages across 12 health facilities and many other key milestones.



Worked with 30 community change agents and 751 parents to strengthen community child protection and safeguarding awareness, reporting and case management.



Engaged 12 health centers and health personnel to ensure that 6,252 adults and 504 children access and utilize health services and information.



667 children and 1,635 adults accessed and utilized socioeconomic information and services within partner self support groups and schools.



Worked with 1,794 schools to enable entry, retention and access to quality education for at least 538,200 children.



Ground breaking ceremony for construction of the Amani Elevator Facility officiated by Mr. Festus Ayikobua, the Maracha District Resident Commissioner (RDC).

# 2022 PROJECTS



## **1** AMPLIFIED COMMUNITY ACTION AGAINST TEENAGE PREGNANCY AND CHILD MARRIAGE (ACAA-TPCM)

Funded through Girls First Fund; the project aimed at, Ending child marriage and teenage pregnancy for prosperity and social economic transformation in Maracha and Arua districts. The project period ran from June 2020 to June 2022 and implemented within Kijomoro, Oleba and Oluffe Sub-Counties in Maracha District, Arua City and Vurra Sub-County in Arua District directly supporting XX within 2022.

## **2** SCHOOL FINANCIAL HEALTH PROJECT

Amani in partnership with Edify is improving learning outcomes and access to affordable education through supporting low cost private christian schools improve aspects of school financial management. In 2022 a total of 1,747 across Gulu, Pader, Mukono, Jinja, Nakasongola, Mpigi, Wakiso, and Kampala City participated in school training on accounting and financial management.

## **3** RIGHT2GROW

The project's ultimate goal is for every child to be able to reach their full potential through ensuring that all children under 5 are well nourished (aligned to SDG 2.2). The project is being implemented by Amani Initiative in Maracha district (Yivu and Oluffe Sub-counties), Arua District (Vurra Sub-County) and Arua City as a sub-grant from the Hunger Project and the Movement for Community Led Development Uganda Chapter under the Dutch Ministry of Foreign Affairs.

## **4** EMPOWERED VOICES

The project is a continuation of the Girls First Fund grant. Under Empowered Voices we are adopting a human centered design process that leverages a community led and gender transformative approaches to ensure that the activities supported under the grant to prevent and respond to child marriage are demand driven and encourage inclusive participation of all relevant stakeholders in Maracha and Arua Districts.

## **5** FOUNDATION FOR LEARNING AND EMPOWERMENT PROJECT.

Under this project; Amani Initiative is directly conducting training for teachers and administrators across government schools in Arua and Yumbe Districts on Value Based Learning with the support of Aga Khan Foundation.

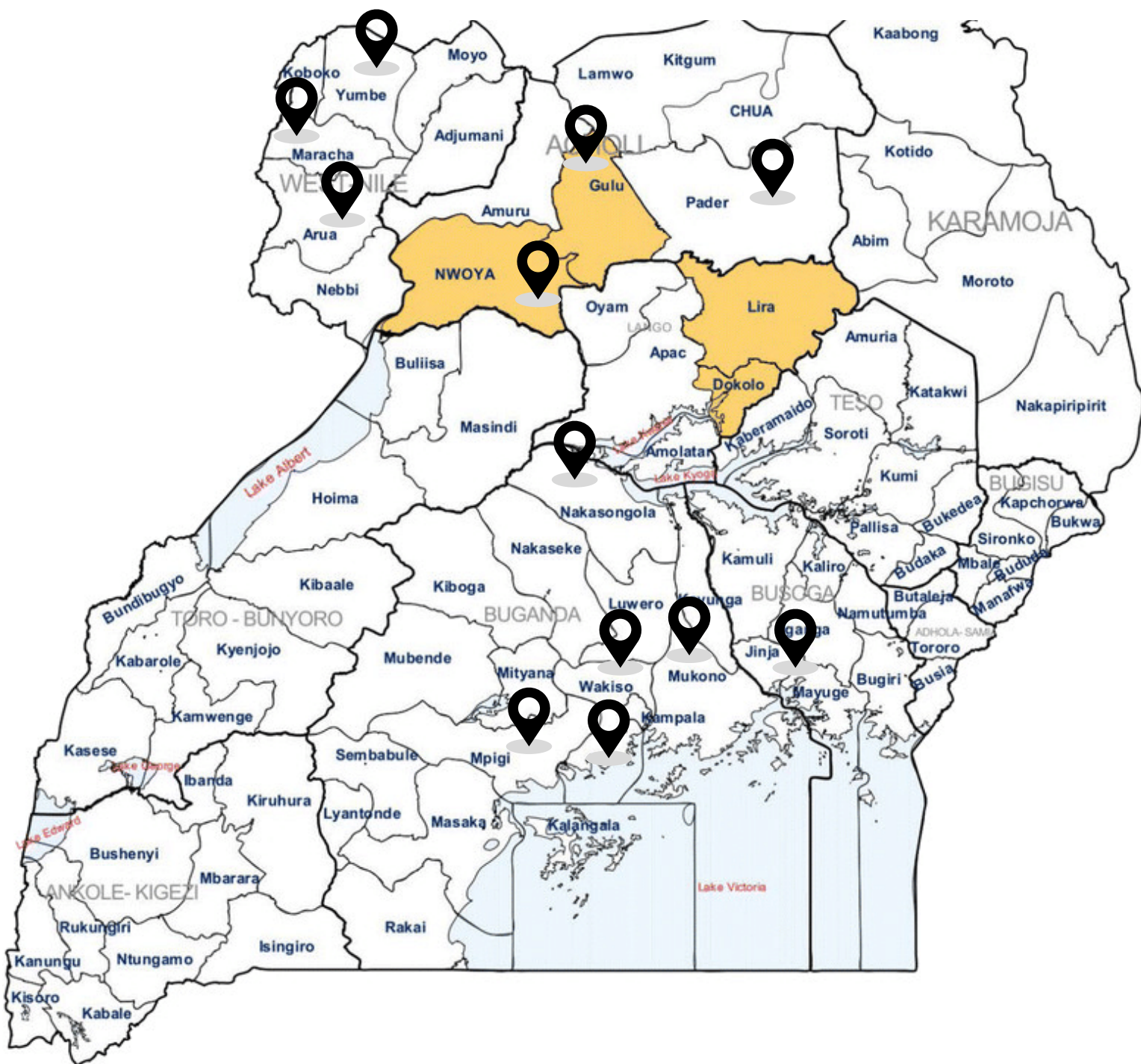
## **6** WEST NILE HIV PROJECT

The project aims to attain and sustain HIV epidemic control in the West Nile region of Uganda through optimization of high impact interventions to achieve UNAIDS 95:95:95 targets; and strengthening national, regional, district level capacities to meet MoH minimum performance. The project is implemented across a network of 12 health facilities in Maracha District with support from Centre for Disease Control through the Infectious Disease Institute.

## **7** PEPFAR HIV, MALARIA ACTIVITY

The project supported through PeaceCorps directly targeted 694 priority population through HIV testing Services, malaria control and or grass root soccer to catch up with the COP21 targets for OVC preventive and priority population prevention in Maracha district.

# 2022 areas of direct implementation.



Amani Initiative has a mandate to implement across Uganda. Within 2022 our interventions focused the West Nile, Acholi, Buganda and Busoga Sub- Regions of Uganda.

We had active direct interventions across:-

1. West Nile Sub- Region (Maracha District, Arua City, Arua District and Yumbe District)
2. Acholi Sub- Region (Gulu, Pader and Nwoya Districts)
3. Buganda/Luwero Sub- Region (Mpigi, Wakiso, Mukono, Nakasongola, and Kampala City)
4. Busoga Sub- Region (Bugweri District and Jinja District)



# EDUCATION



"Child brides are likely to DROP OUT OF SCHOOL, hindering their personal development, preparation for adulthood and their ability to contribute to their family and community." Girls Not Brides

Within 2022, our education thematic area prioritized (1) re-entry of child mothers back into school as part our response to Covid19 ; and (2) value based education training for teachers and administrators of government schools.

A total of 1,641 individuals who included child mothers, educators and parents directly benefited from our 2022 education-related interventions with over 4,800 indirectly benefiting as the result of our education systems strengthening interventions across 31 partner schools.

We also organized School Debate Competitions with the support of the Girls First Fund across 6 government schools in Maracha District under the topic, "Pregnant Girls Should be allowed back into school." The debates created further awareness among learners on the need to support child mothers safely return to school without stigma.

Through the Foundation for Learning and Empowerment Project; 225 educators and teachers across 10 schools were trained on value based education approaches. These approaches create a strong learning environment that enhances academic achievement and develops students' social and relationship skills that last throughout their lives.

We directly engaged and followed up with 1,412 parents to be in position to return their children especially teenage mothers back into school after the closure of schools due the Covid-19 lock down.

Our scholarship program under Keep Me In School also on boarded 4 girls who have been supported to return and stay in school during 2022.

# CHILD PROTECTION & SAFEGUARDING



Within 2022, our Child Protection and Safeguarding team directly worked with 30 community change agents, and 16 schools to promote awareness, case management and reporting mechanism for violence against in and out of school children.

Together with Girls Not Brides Uganda we organized in the 2022 National Girl pre- Summit 18th November under the theme “Children need a Society Free from Child Marriage and Teenage Pregnancy.” which converged 158 participants across Northern Uganda.

16 partner schools under the Empowered Voices project were supported with information on teachers code of conduct through talking compounds. This focused on guiding schools establish guidelines on child protection and safeguarding. This intervention has made schools safer for at least 19,200 children who attend these schools.

We also engaged with the local officials to disseminate the parenting guidelines to 751 parents during parents meetings in school as well as community dialogues. The guidelines are key at addressing the challenges parents face in raising their children as indicated in most of our community dialogues.

# CHILD, ADOLESCENT, AND MATERNAL HEALTH



Within 2022; our child, adolescent and maternal health thematic area aimed at interventions focused on providing key health focused information and services reaching out to 6,756 key populations.

Under the West Nile HIV project 5,461 individuals directly accessed information and services related to attaining and sustaining HIV control within Maracha District. The activities implemented included HIV and TB testing, follow up of lost clients and facility linkages.

Through the Right2Grow program we directly engaged 634 individuals who included children, mothers and policy makers to understand, demand and invest in WASH and nutrition services as part of ensuring that every child is able to reach their full potential. Children of teenage mothers are at a higher risk of stunting due to poverty as well as ignorance of best WASH and nutrition practices of the child mothers.

Together with PeaceCorps Uganda, 694 individuals who included adolescents, pregnant mothers, key populations such as men in uniform and community health workers accessed malaria control, sexual & reproductive health and HIV testing services.

Our Child, Adolescent and Maternal Health thematic heavily relied on leveraging existing community structures and networks.

Our Linkage Referral Assistants were attached across the 12 health centres in Maracha to facilitate community facilitate linkage in accessing HIV/TB services.

Members of Village Health Teams have been key at community sensitization of malaria control, proper hygiene and nutrition best practices within Maracha and Arua Districts.

# SOCIOECONOMIC EMPOWEREMENT



Poverty is not a key driver of child marriage and teenage pregnancy but also directly affects child brides.

Child brides do not receive the educational and economic opportunities that help lift them and their family out of poverty. **THEY ARE MORE LIKELY TO BE POOR AND REMAIN POOR.**

Our socioeconomic empowerment program directly focused on supporting child mothers within 4 self support groups to access relevant social and entrepreneurship skills and opportunities. The program also invested in supporting low cost private schools improve their financial health. Most of these schools were hit hard as the result of the long close out of schools as a precaution to Covid19 prevention.

This risked school closure and widening the gap to access to education for some of the most vulnerable children in our community.

A total of 2,302 people directly benefited from these programs. 155 of these people included young mothers within our 4 self support groups in Maracha and Arua Districts

1,747 low cost private schools across Gulu, Pader, Kampala, Mukono, Wakiso, and Jinja Districts were trained during in school training's and mentorship. The training's focused on issues around business and accounting management of a school.

As a growing organization we prioritize and invest in institutional capacity strengthening through building staff capacity, strategic partnerships and resource mobilization dedicated to prevention and response to teenage pregnancy and child marriage.

Within 2022; all our staff participated from 10 training and exposure opportunities within our networks. The training not only supported their service delivery but also build their own career skills and opportunities.

The organization also launched the construction of the Amani Elevator Facility at a during the 10 years anniversary celebrations attended by over 300 people.

The Amani Elevator Facility in Maracha District is to house the Amani Initiative Head Offices, Community Hall and Life Skills Transformation space for at risk children and youths.

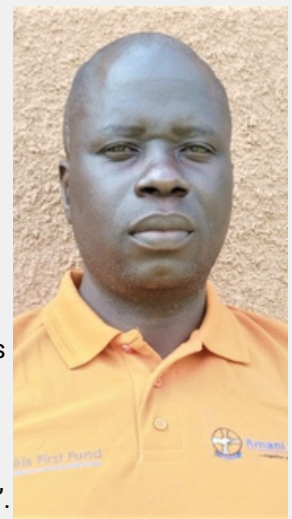

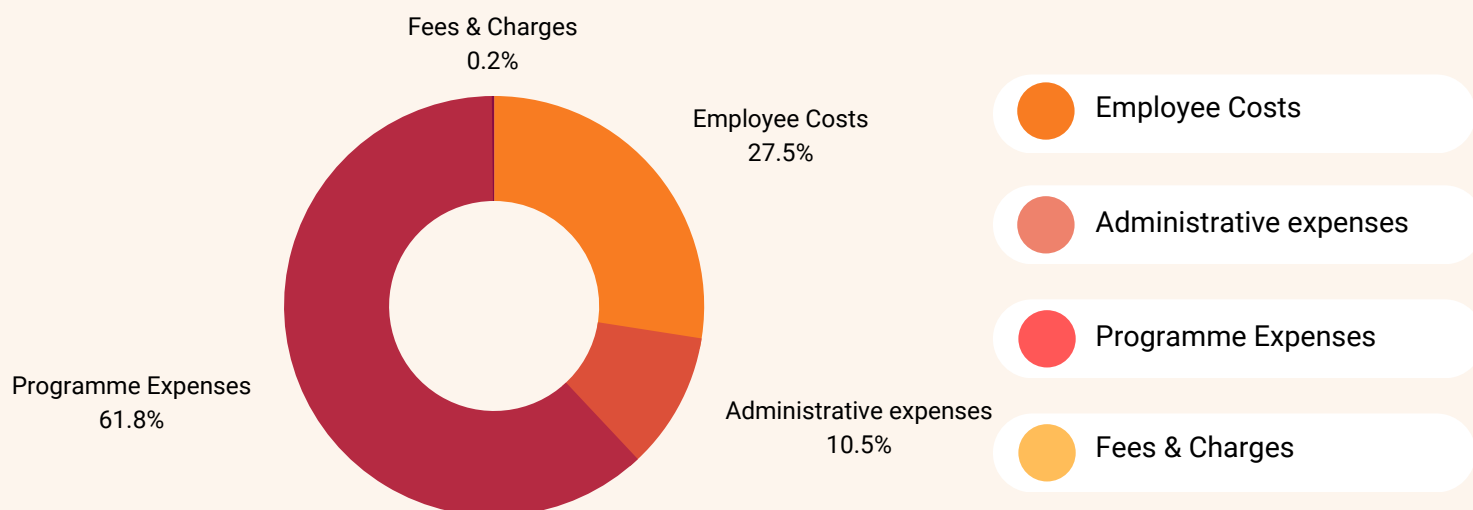
