EXECUTIVE SUMMARY



Amani Initiative, a grassroots non-profit organization founded in Uganda in 2012, is dedicated to combating harmful practices against children and women through community-led interventions. Focused on education, child protection, socioeconomic empowerment, and health, the organization aims to foster sustainable solutions and uphold human rights.

Uganda faces persistent challenges such as child marriage and teenage pregnancy, despite constitutional protections. Shockingly, one in four Ugandan women aged 15-19 experiences pregnancy or childbirth before 18, leading to high school dropout rates among girls and negative socioeconomic impacts. Urgent action is needed, with 64% of adolescents engaging in sex before 18, highlighting the severity of the issue.

The work of Amani Initiative is dedicated to addressing these challenges as guided by the 2023- 2027 strategic plan dedicated to preventing and responding to child marriage and teenage pregnancy. It is also important to note that this work aligns directly with several Sustainable Development Goals (SDGs), including eradicating poverty, ensuring zero hunger, promoting good health and well-being, providing quality education, achieving gender equality, fostering economic growth, and establishing peace, justice, and strong institutions. By addressing these challenges, the organization aims to create a more sustainable and equitable future for all.

In 2023, Amani Initiative implemented various impactful projects and activities in Uganda. These included supporting schools and learners, establishing safe spaces for victims of gender-based violence (GBV), providing socioeconomic empowerment through business skills training, and offering health-related information and services. The organization also focused on institutional capacity strengthening through staff training and engagement, as well as resource mobilization.

The achievements of Amani Initiative in 2023 underscore its commitment to combating harmful practices and promoting the well-being of children and women in Uganda. The organization calls upon stakeholders to join its mission in creating a more sustainable and equitable future, in line with the Sustainable Development Goals.

As we reflect on the inaugural year of our 2023–2027 strategic plan dedicated to preventing and responding to teenage pregnancy and child marriage, I am filled with immense gratitude for the unwavering dedication and support from our donors, staff, volunteers, and district officials. Your commitment has been instrumental in driving forward our mission to combat harmful practices against children and women in Uganda.

In our relentless pursuit to address the alarming rates of child marriage and teenage pregnancy in Uganda, our efforts in 2023 have yielded tangible results. Through projects like Right2Grow, Keep Me In School, and Empowered Voices, we've empowered vulnerable youth, provided educational support, and bolstered community-led interventions.

In education alone, we've supported 309 schools with a total enrollment of over 90,000 learners and engaging nearly 1,000 school administrators. Furthermore, our initiatives have facilitated access to justice for victims of sexual and physical violence, with 5 cases successfully supported to follow up legal proceedings.

In socioeconomic empowerment, we've trained over 160 child mothers and women, equipping them with essential business skills and financial literacy knowledge. This has led to significant savings, totaling over 16 million Ugandan Shillings, and the training of 279 business owners.

Additionally, our focus on child, adolescent, and maternal health has reached over 3,600 individuals with health-related information and services, impacting 12 health institutions through personnel attachments.

As we move forward, the need for collective action becomes ever more pressing. Child marriage and teenage pregnancy not only rob young Ugandans of their futures but also hinder the achievement of critical Sustainable Development Goals. Together, we can create a brighter, more equitable future for Uganda's youth.

I invite potential supporters to join us in our mission. Your involvement can make a profound difference in the lives of countless children and women across Uganda. Whether through financial contributions, volunteering, or spreading awareness, every action counts in our collective journey toward positive change.

Did you know?

Child marriage and teenage pregnancy plague Uganda, despite constitutional protections. Shockingly, one in four Ugandan women aged 15–19 experience pregnancy or childbirth before 18, leading to a staggering 22.3% of school dropouts among girls. Unsafe abortions afflict 28% of child mothers, while the nation loses UGX 645 billion annually as the result of child marriage and teenage pregnancy. With 64% of adolescents engaging in sex before 18, urgent action is needed. Supporting initiatives against these practices is crucial to secure a better future for Uganda's youth.

Failure to tackle child marriage and teenage pregnancy jeopardizes our ability to achieve several critical Sustainable Development Goals (SDGs). These goals encompass eradicating poverty (Goal 1), ensuring zero hunger (Goal 2), promoting good health and well-being (Goal 3), providing quality education (Goal 4), achieving gender equality (Goal 5), fostering economic growth (Goal 8), and establishing peace, justice, and strong institutions (Goal 16). Addressing these challenges is pivotal to creating a more sustainable and equitable future for all.

What we are doing?



Amani Initiative, a grassroots non-profit established in Uganda in 2012, is committed to combating harmful practices against children and women through community-led interventions.

With a strategic focus on education, child protection, socioeconomic empowerment, and health, it operates a network spanning health facilities, schools, and community agents. Emphasizing low-cost, high-impact interventions and gender inclusivity, the organization prioritizes human rights and sustainable solutions.

2023 PROJECTS IN BRIEF

In 2023, Amani Initiative spearheaded five strategic projects in line with our mission to eradicate child marriage and teenage pregnancy in Ugandan society. These projects were strategically aligned with our 2023–2027 plan, focusing on education, child protection, socioeconomic empowerment, and maternal health. Additionally, efforts were made towards institutional strengthening and sustainability. Here are key highlights from the implemented projects.

1) Amani Elevator Facility

This project is dedicated to construction of the Amani Elevator Facility which will house the Amani Initiative Headquarters, a Community Hall, and a Life Skills Transformation space for at-risk youth, girls and women. The facility once completed will be a safe haven with all necessary amenities, fostering sustainability through local revenue generation. Construction began in 2023, with roofing starting in 2024, funded jointly by the community and friends of Amani Initiative across the globe.

2) RIGHT2GROW

The Right2Grow project is dedicated to mobilizing communities within Oluffe Sub-County in Maracha District to demand and invest in basic social services, nutrition, and WASH practices. With private sector partnerships, it aims to enable every child to reach their full potential. The project running till 2025 is implemented as consortium led by Hunger Project Uganda through funding from the Dutch Ministry of Foreign Affairs.

3) EMPOWERED VOICES

Empowered Voices prevents and responds to child marriage through empowering frontline communities and vulnerable young women in Maracha and Arua through community-led interventions. Supported by the Girls First Fund, it aids 16 low-cost schools, 480 learners, and 4 self-support groups, empowering 160 child mothers to speak out against child marriage and improve their living conditions.

4) WEST NILE HIV PROJECT

The West Nile HIV Project aims to achieve comprehensive HIV/AIDS control in Uganda's West Nile region, aligning with PEPFAR's 95:95:95 targets. Collaborating with 10 local health facilities, activities included Community Index testing, client follow-up, and Community-Facility linkages, supported by the Infectious Disease Institute and Center for Disease Control since 2020.

5) School Systems Strengthening program.

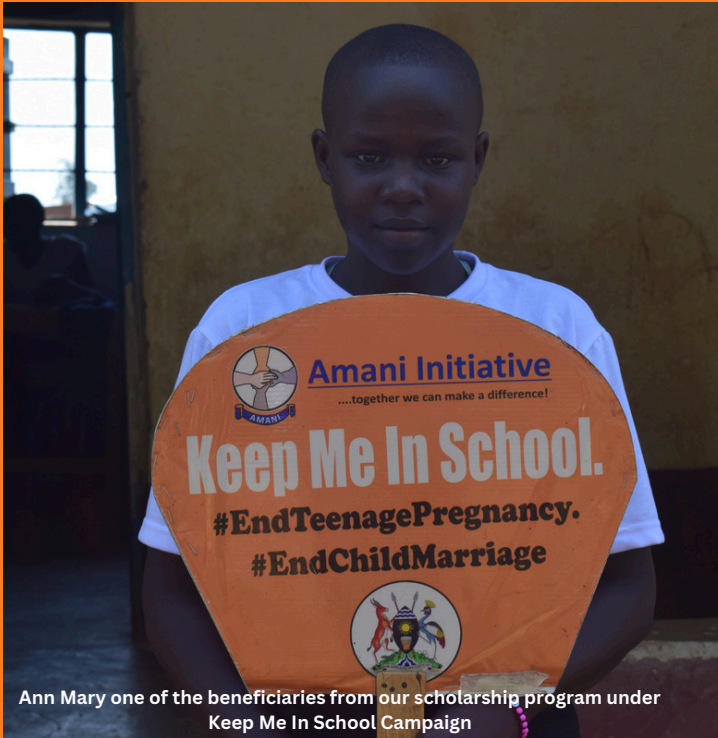
The School Systems Strengthening program together with Edify Uganda is enhancing survival and resilience of low-cost schools by improving management through targeted training and support in financial management and functional school policies. Within 2023 we supported 309 low-cost schools across Wakiso, Mpigi, Nakasongola, Kampala, Jinja, Luwero, and Gulu Districts with a total learner enrollment of 90,513.

ENABLING EQUAL AND QUALITY EDUCATION OPPORTUNITIES FOR ALL.

In 2023, Amani Initiative education programming focused on strengthening school systems, enhancing learning outcomes, and promoting enrollment and retention for at risk children.

We implemented the Empowered Voices project, funded by Girls First Fund, collaboration with Edify Uganda under the School Systems Strengthening program, and the Keep Me In School Campaign, supported by individual donors to facilitate equal and quality education opportunities for children in low cost schools.

These projects involved working with parents, learners, educators and school administrators across 309 low cost schools.

School system strengthening for 309 low cost schools.

Amani Initiative focused on supporting low-cost schools through improved financial management as part of school system strengthening. Our hands-on training covered budgeting, record-keeping, compliance, and school management structures to counter poor financial practices. This initiative supported 309 schools, benefiting 90,513 students, with 972 stakeholders engaged in training sessions.

Additionally, we participated in the Ajono Primary School PTA meeting in Arua District, addressing academic performance, infrastructure, and governance. The meeting, attended by 116 people, including two with disabilities, launched the school's 2023 improvement plan, ensuring ongoing progress and quality education. These efforts underscore our commitment to fostering sustainable educational environments and securing quality education for all.

Improving learning outcomes for at risk children

To improve learning outcomes for at-risk children, the Empowered Voices project, financed by the Girls First Fund, targeted learners, parents, and educators. We engaged 131 parents, guided by the Ministry of Gender, Labor, and Social Development's positive parenting guidelines, to support their children's education. Additionally, 638 learners from 16 partner schools in Arua and Maracha Districts participated in outreaches emphasizing education and academic strategies.

Furthermore, 113 educators and committee representatives received Value Based Education Training through collaboration with the Agha Khan Foundation. A pivotal PTA meeting at Ajono Primary School in Arua District addressed key issues and launched a comprehensive improvement plan for the year, ensuring continued progress.

Supporting enrollment and retention in school

We prioritized enrollment and retention in schools for vulnerable children in Arua and Maracha Districts where we awarded additional full scholarships to six vulnerable girls, addressing the barrier of financial constraints to education.

Recognizing the impact of menstrual hygiene on attendance, we distributed safe, reusable sanitary pads to 638 girls, ensuring they could menstruate with dignity and remain in class. These pads, provided by Together Alive Health Initiative (TAHI) with support from Afripads Foundation, are enabling girls to pursue their education uninterrupted.



Provision of appropriate sexual, reproductive and health information and services.

Welcome to our Child, Adolescent, and Maternal Health program, a cornerstone in our mission to address the health challenges surrounding teenage pregnancy and child marriage. At Amani Initiative, we're committed to promoting family planning, sexual and reproductive health, menstrual management, nutrition, and combating HIV/AIDS. In 2023, we undertook two key activities: supporting community members in accessing and utilizing vital health services and information, and enhancing the capacity of community structures to deliver comprehensive health-related services. These efforts, implemented within the Right2Grow and West Nile HIV projects in Arua and Maracha Districts, signify our dedication to ensuring the well-being of vulnerable populations.

Supporting members of the community to access and use relevant health related services and information.

Through the Right2Grow program and Empowered Voices project, we conducted community awareness sessions on sanitation, sexual and reproductive health, family planning, and nutrition, reaching over 3,650 community members.

Additionally, 3,462 individuals accessed health services, including family planning and HIV/TB testing, facilitated by Linkage Referral Assistants under the West Nile HIV project. Activities included Community Index testing, follow-up of lost clients, home-based care, and targeted testing initiatives. These efforts aim to improve community health outcomes and empower individuals to make informed decisions about their health and well-being.

Capacity strengthening of community structures to provide health related information and services

Amani Initiative strengthened community health service delivery by building capacity within local structures. Partnering with 10 health centers in Maracha District, including Eliofe, Kamaka, Kijomoro, Maracha, Nyadri, Oleba, Oluvu, Ovujjo, Tara, and Wadra, with a total catchment of around 200,000 people. Through the West Nile HIV project, Linkage Referral Assistants at these centers supported HIV prevention efforts and monthly supervisions improved data management for patient follow-up. Additionally, we collaborated with Hunger Project Uganda's Right2Grow program to support District and Sub County Nutrition Coordination Committees, enhancing nutrition and WASH service delivery. Through the Maracha District CSO Platform Network, we bolstered CSO participation in advocacy and monitoring frameworks for effective nutrition initiatives.



SOCIOECONOMIC EMPOWERMENT

Welcome to our Socioeconomic Empowerment thematic area, dedicated to addressing the intertwined issues of poverty, teenage pregnancy, and child marriage.

Our multifaceted approach in 2023 included establishing and strengthening disadvantaged groups or women-led SACCOs or Village Savings and Loans Associations, supporting child mothers and marginalized women in income-generating activities, promoting financial literacy and inclusion for at-risk women and girls, and providing essential training to small and medium-sized businesses on effective business and financial management. These activities reflect our commitment to empowering individuals and communities for lasting socioeconomic transformation.

Training small medium businesses on business and financial management

Amani Initiative collaborated with Edify Uganda to train 279 small and medium-sized business owners, primarily in the education sector, focusing on financial management and compliance. This aimed to bolster profitability and resilience amidst economic challenges, safeguarding livelihoods. These businesses supported were across the districts of Kampala, Luweero, Mpigi, Jinja, Kamuli, Iganga, Mukono and Wakiso.

Additionally, under the Empowered Voices project, we distributed bean seedlings to 63 child mothers in Maracha, enhancing agricultural productivity. In Arua District, 15 child mothers received training in personal financial management, equipping them with essential skills for financial planning and stability.



Investing in women led self support groups.

Through the Empowered Voices project financed by the Girls First Fund, we supported child mothers, women, and disadvantaged individuals to initiate or strengthen income-generating activities. This included 160 child mothers and young women across four self-support groups, who were trained to build sustainable livelihoods and achieve financial independence through entrepreneurship skills.

Financial literacy and inclusion

In 2023, Amani Initiative delivered financial literacy training to 439 at-risk women, girls, and disadvantaged groups, fostering economic empowerment. Through the Empowered Voices Project, four self-support groups of child mothers and young women amassed savings totaling 16,716,000/=.

These savings empowered participants to invest in their personal businesses and address emergencies, contributing to breaking the cycle of poverty and securing their financial futures.



CHILD PROTECTION AND SAFEGUARDING

Welcome to our Child Protection and Safeguarding thematic area, where we champion the safety and well-being of every child. Our mission is clear: to prevent, respond, and manage violence against children while eradicating the scourge of teenage pregnancy and child marriage. In 2023, our efforts were focused on two key activities.

Firstly, we supported victims of gender-based, sexual, and physical violence, providing them with the necessary care and resources. Secondly, we worked tirelessly to strengthen community structures in Arua and Maracha Districts, empowering them to prevent, identify, and respond to instances of violence effectively. These initiatives were made possible through the generous support of the Girls First Fund under the Empowered Voices project.

STRENGTHENING COMMUNITY STRUCTURES TO PREVENT, IDENTIFY AND RESPOND TO SEXUAL AND PHYSICAL VIOLENCE.

Our community-focused initiatives to combat sexual and physical violence made significant strides. We established four safe spaces for GBV survivors, reaching 1,930 individuals with vital information on prevention and response to physical and sexual violence. Through 16 community events and dialogues, we empowered communities to address violence against children proactively.

To engage children in child protection, we conducted awareness sessions on child protection in 15 primary schools across Maracha and Arua districts with 1,830 learners involved. School debates further explored the role of schools in child protection, involving 369 learners from six schools.

SUPPORTING VICTIMS OF GENDER BASED, SEXUAL AND PHYSICAL VIOLENCE.

Our efforts in supporting victims of gender-based, sexual, and physical violence has seen access to justice for 5 victims from documented 10 incidences of sexual and physical violence, and successfully reported 5 cases for prosecution.

These achievements signify our dedication to providing essential support and advocating for the rights of survivors, marking progress in our ongoing battle against gender-based violence. Though it should be noted that we are still grappling challenges related to limited internal capacity and referral pathways to better manage cases of violence against children in the community.

INSTITUTIONAL CAPACITY STRENGTHENING

The Institutional Capacity Strengthening Department played a pivotal role in advancing the goals of Amani Initiative's strategic plan (2023–2027). Activities focused on staff capacity enhancement, maintaining organizational visibility and branding, reinforcing internal policies and structures, and fostering partner engagement and resource mobilization.

Key among our deliverables was the construction of the Amani Elevator Facility, set to house our headquarters, a community hall, and a life skills transformation space for at-risk children and youth. This facility aims to be Uganda's premier safe space, generating local revenue to sustain our efforts in combating teenage pregnancy and child marriage nationwide.

STAFF CAPACITY STRENGTHENING

As part of our commitment to build capacity of our staff for career growth and quality service delivery, our staff underwent comprehensive training opportunities within 2023 in the fields of Budget Monitoring, Expenditure Tracking, and Citizen Voice and Action material development, organized by World Vision Uganda and CEEGA under the Right2Grow program. Additionally, Social Behavior Change Training by Communication for Development Foundation Uganda aimed to enhance communication skills.

Networking events like the West Nile Region National Youth Action Platform (NYAP) Meeting and initiatives like the Girls First Fund Grantee Convening Meeting and the Women's Voice and Leadership Project Launch further empowered staff to drive impactful change.

STRENGTHENING AND MAINTAINING AMANI INITIATIVE VISIBILITY AND BRANDING

Amani Initiative bolstered visibility and branding via 342 social media posts, directly engaging 11,930 individuals across platforms with awareness and advocacy messages addressing child marriage and teenage pregnancy.

CONSTRUCTION OF THE AMANI ELEVATOR FACILITY

The construction of the first block of the Amani Elevator Facility commenced in 2023, currently progressing to the beam level, with roofing scheduled for 2024. This block will accommodate administrative offices, a training room, board room, and a nursery for children accessing services. Over 45,000,000/= has been invested in the project, supported by contributions from the community and individual friends of Amani Initiative.

STRENGTHENING INTERNAL POLICIES AND STRUCTURES

Amani Initiative approved a 2023–2027 strategic plan aiming to eradicate child marriage and teenage pregnancy. Additionally, an ICT policy was implemented to streamline communication, vital for organizational efficiency.



Partnerships and Networking opportunities

In 2023, Amani Initiative forged significant partnerships and collaborations to advance its mission. Key highlights include signing MoUs with Safepad Uganda for Menstrual Hygiene and with the Hunger Project under the Right2Grow Program. Additionally, partnerships were established with the Movement for Community Led Development and entry into networks like the West Nile Civil Society Network and the National Youth Advocacy Platform.

Moreover, Amani Initiative's application to join the AfriYAN Uganda Chapter was accepted, and recognition certificates were awarded to notable partners such as PeaceCorps Uganda, UN Women Uganda, Joy for Children, Girls First Fund and others who contributed to our work between 2012- 2022. Partner meetings were held with organizations like MEMPROW Uganda and Save the Children Netherlands. The Initiative also showcased its work internationally at conferences like the International Scientific Conference RESEARCH for NUTRITION in France and the Micronutrient Forum 6th Global conference in The Hague.

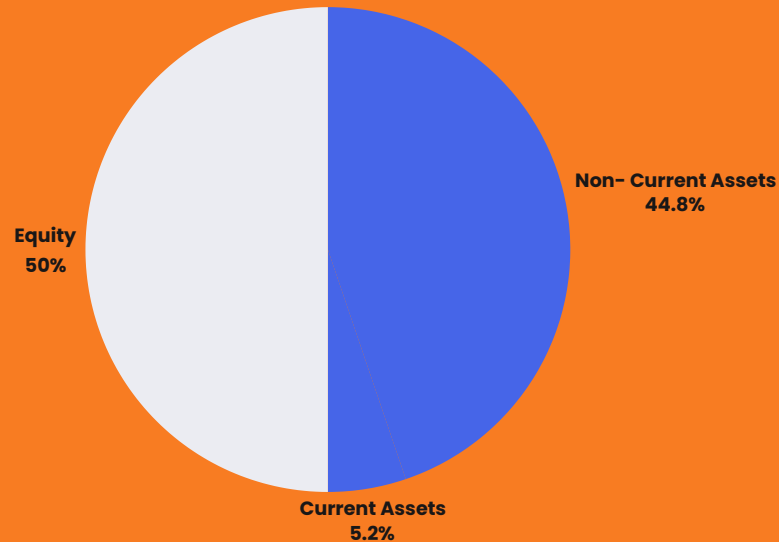

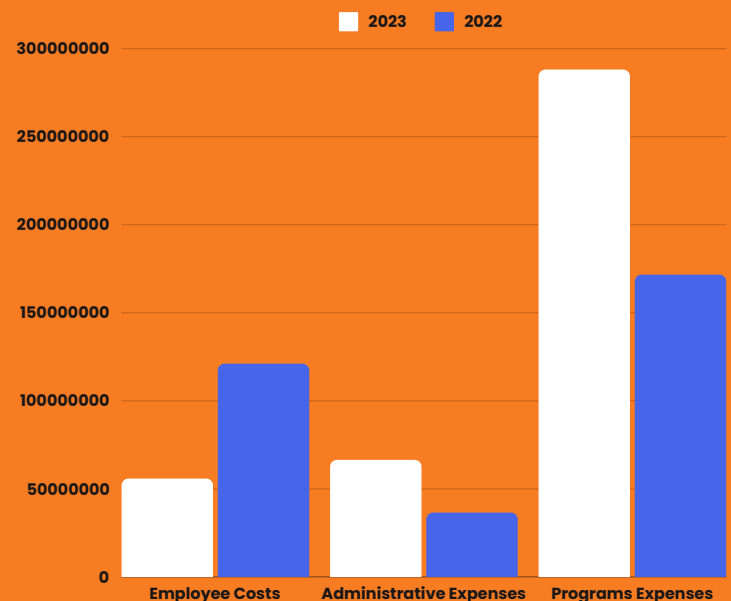
Statement of Financial Position

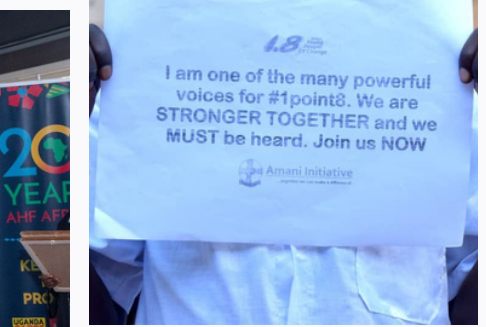
